2025.97 Ward Councillors' Reports

Ward Cllr Hammond provided the following updates;

- The gravel has been cleared from beneath the bridge on the A1079
- The volunteer Flood Wardens have been contacted by ERYC and training will be delivered to them. If anyone else would like to volunteer, please contact the Ward Councillors
- The [Fair Funding Review 2.0](#) is expected to negatively impact ERYC's budget through changes to funding for Councils in more rural areas and a reduction in the percentage of business rates which are retained by local authorities. As a result, Council Tax is likely to be increase by the full 5% each year for the foreseeable future.

St Martins Churchyard, Town Street, Hayton, East Yorkshire YO42 1RR
TPO - ST MARTIN'S CHURCH YARD, HAYTON - 1979 (REF 342) T1, T2 & T8 - Crown reduce 2 no. Yew trees (G1) by 5 metres in height and reduce by 4 metres at either side to maintain clearance to overhead wires and re-shape to improve the shape in accordance to the height of the wires; Crown reduce 1 no. Sycamore tree (T8) to 5-6 metres in height due to dieback and to see if the crown will re-sprout

2025.100 Footpaths on Town Street

To revisit the issue of the poor condition of footpaths on Town Street in Hayton.

Cllr Ellis again raised the issue of the poor condition of footpaths on both sides of Town Street, together with the impact from an overgrown hedge on the corner near The Vicarage. It was also noted that problems are often exacerbated by works to driveways.

ACTION: Ward Cllr Hammond to raise with ERYC Highways, and the resident to be asked to cut back the overgrown hedge to allow the safe passage of pedestrians and pushchairs.

2025.101 Environmental Policy

To review and adopt an Environmental Policy in connection with the grant application to the "Do It For East Yorkshire" fund for a history board in each village.

RESOLVED: Adoption of the Environmental & Sustainability Policy was proposed by Cllr Ellis and seconded by Cllr Wagstaff with all in favour.

2025.102 Clerk's Report

To receive updates from the Clerk.

- The Clerk had met with members prior to the Meeting and an interim appraisal was held
ACTION: Clerk to add a Confidential Item to the Agenda for the Meeting in December for discussion and agreement regarding the Clerk's salary
- The Clerk advised members that the Precept Demand for 2026/27 would soon be due for completion and asked for consideration to be given to any projects or one-off items of expenditure which will need to be included.

2025.103 Councillors' Reports

*To receive updates from Councillors on any urgent issues which have arisen since the Agenda was published. **Please note that no decisions can be made during this item.***

- Cllr Ward raised the issue of the lighting at the Pocklington Household Waste Recycling Site being on at all hours and creating light pollution
ACTION: Ward Cllr Hammond to report this to ERYC
- Cllr Wagstaff noted a request from a resident for perspex windows in the bus shelter, and also raised the issue of trees along the A1079
- Cllr Sedcole noted that the "Give Way" markings on the road between Burnby and Nunburnholme were worn, and that the edges of the road surface were crumbling
ACTION: Ward Cllr Hammond to include the worn markings as part of a scheme to restore road markings in the wider area
- Cllr Sedcole also raised the issue of foliage growth in The Beck at Burnby, with the Syke being particularly overgrown
ACTION: Ward Cllr Hammond to raise this matter with ERYC
- Cllr Stonehouse again raised the issue of the collapsed culvert
ACTION: Ward Cllr Hammond to follow up with ERYC Highways
- Cllr Ellis noted that some of the tape which had been applied to the bollard lights on the eastbound carriageway of the A1079 had peeled away or had become detached, resulting in more light shining onto the road

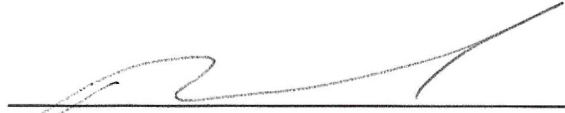
