2025.70 Live Labs 2

To receive an update on the Live Labs 2 project from Karl Rourke of ERYC.

Karl Rourke provided the following updates;

- the bollards on the westbound side have been deemed unsuitable for this application and are due to be removed before the end of the year. As a temporary solution, they will be partially covered so that the lights are much less visible to road users
- testing is being carried out to find the right balance of lighting on the pathways so that dark spots are eliminated without over-lighting these areas
- a survey around safety in pedestrian areas is due to be carried out in November. This is targeted at elements which cannot be readily measured by technology
- a very large amount of data has already been collected and is being downloaded for analysis. This is expected to provide a detailed breakdown of pedestrian, bicycle and vehicle numbers, together with vehicle speed and "hotspot" days / times
- The old streetlighting is expected to be removed after April 2026

Parish Councillors and members of the public raised points regarding the difficulties caused by the lights when exiting driveways, a damaged bollard near Everingham Lane and a crossing light which appears to be constantly on.

ACTION: Karl Rourke to investigate these issues and report back at the Meeting in October.

Ward Cllrs Hammond and West provided the following updates

- The Burnby Flood Plan will be overseen by East Riding of Yorkshire Council who will provide insurance and training for volunteer Flood Wardens. There will be no direct involvement from the Parish Council. The role of the Flood Wardens will be to report instances of flooding and to liaise with the relevant emergency contacts

Ward Cllr West is due to attend a briefing about this topic on Tuesday 16th September and will provide a further update following that meeting

- Ward Cllr Hammond advised that he will be in contact with the relevant teams from ERYC to have the sandbank under the bridge of Hayton Beck removed
- Humberside Police have launched a new Community Safety Mounted Volunteer scheme for rural horse riders to share information and report incidents of concern
