46/11 Election of officers of Hayton and Burnby Parish Council.

a/ Chairman. Cllr Nicholson proposed Cllr Drewery. Seconded by Cllr Thackray. Cllr Drewery was elected.

48/11 Matters arising

Highways footpath drain outside The Plough. This has been reported a number of times with the Clerk even sending photos supplied by Cllr Thackery. Eryc reported they would look at it again. Cllrs will point it out again on the street scene walkabout.

Gas Pipe. Gas company have been out and removed the plastic outer to the pipe. Clerk had spoken to them and they said they was just waiting for the environment agency to give the ok and the work will commence mid-July.

Beck Clearance and Ownership. A lengthy discussion took place on the ownership of various stretches of the beck. Cllr Thackray had met with the Environment Agency who hadn't realised how bad the beck had become, they have promised to undertake the work to the beck where they are

responsible. The Beck from the duel carriageway toward Burnby is the responsibility of the riparian owners. If they do not maintain the beck then the Drainage board do have the power to have the work carried out then charge the riparian owners. Cllr Thackray asked who would have the necessary authority to go the beck to check it out, not Parish Councillors as they would be trespassing. Clerk to check with the Market Weighton Drainage Board. Agreed that if the beck is to flow properly, then it all needs doing and not just bits. Clerk to enquire if there is any grant money available for this sort of work. Discussion followed regarding the state of the drains in Burnby, cllr Nicholson presented some photos which he had taken showing the problem. These to be shown to the officers during the walkabout in in June.
